*2012 "Choose Your Cruise"* benefits the Orange Grove Center,  
which is a 501(c)(3) organization.

*2012 "Choose Your Cruise"* has been approved under, and is subject to,  
the provisions of the Tennessee Charitable Gaming Law.  
The net proceeds will benefit Orange Grove Center, Inc.

1. The *2012 "Choose Your Cruise"* drawing will take place at Orange Grove Center on Friday, April 13, 2012, at Orange Grove Center's main campus at 615 Derby Street. Chattanooga, TN. The drawing will take place at about 3:30 p.m. (ET).
2. Sweepstakes tickets will be numbered from 1-10,000 with a tear off stub given to the purchaser. The prize package will be awarded to the individual whose name appears on the first ticket pulled. The prize is a 7-day cruise package for two people including \$1,500.00 for travel to the port of departure.
3. Each *2012 "Choose Your Cruise"* sweepstakes ticket must be filled out and delivered to Orange Grove Center or an authorized representative of Orange Grove Center prior to noon the day of the drawing to be eligible to win. No person under the age of 18 may purchase a ticket. Sufficient evidence of the age of the ticket purchaser may be required.
4. The winner will be notified by telephone or certified U.S. mail, at the number or address set forth on the entry portion of the *2012 "Choose Your Cruise"* sweepstakes ticket. Upon transfer of the winning ticket, the winner bears full custody and control of the prize certificate, and releases the Tennessee Jaycee Foundation and Orange Grove Center and its agents from all responsibility thereafter.

The winner does not have to be present to win. In keeping with the State of Tennessee's rules on charitable gaming events, no one under the age of 18 may purchase a ticket or be awarded the prize. Also pursuant to state law, no member of Tennessee Jaycee Foundation's board of directors or any officer or employee, nor any member of their family residing as a member of the same household in the principal place of residence of any such person may purchase a ticket or be awarded the prize.

The name of the winner may be obtained from Tennessee Jaycee Foundation by sending a written request and a self-addressed, stamped return envelope to Tennessee Jaycee Foundation at University Tower- Suite 600, 651 East Fourth Street, Chattanooga, TN 37403. If the winner does not make arrangements to claim his or her prize from Tennessee Jaycee Foundation on the day of the

drawing or at the Orange Grove Center's main campus on or before April 27, 2012, a representative of Tennessee Jaycee Foundation will select a substitute winner based on a random drawing of the remaining entry tickets.

In the event that the individual whose name is entered on the winning ticket is ineligible to receive the prize, Tennessee Jaycee Foundation will select a substitute winner based on a random drawing of the remaining tickets.

5. Any and all taxes and similar fees are the sole responsibility of the winner. No cash equivalent prizes will be provided in lieu of the designated prizes.
6. By entering, each entrant releases Tennessee Jaycee Foundation and its employees, directors, volunteers, and Orange Grove Center and its employees, directors, volunteers, and all other related agents from any and all liability with respect to the prize, the cruise, and/or this sweepstake event.
7. By entering, the winner consents to promotional use of his or her name and likeness for this and future events by Tennessee Jaycee Foundation, Orange Grove Center, and related agents without additional compensation.
8. Chances of winning depend on the total number of qualified entries. A maximum of 10,000 tickets will be available.
9. This event is subject to all applicable federal, state and local laws and regulations.
10. The drawing will be audited and verified by an audit committee of Tennessee Jaycee Foundation. All decisions and interpretations of rules and regulations will be made by Tennessee Jaycee Foundation's 2012 "Choose Your Cruise" sweepstakes committee and its judgment shall be final.
